NEW BUSINESS

Proposed Resolution 2020-2316; Approving the Execution of a Revised Recapture Agreement with Alton Industries Ltd. Group and the Extension of the Inspection Period Until January 8, 2020.

Authorizes an extension of the Inspection Period under the Vacant Land Sales Agreement with Alton Industries Ltd. Group, repeals Resolution 2019-2312 and approves a Revised Recapture Agreement setting forth the actual recapture costs for the property directly to the north of the 12-acre parcel being purchased by Alton Industries Ltd. Group under the Vacant Land Sales Agreement.

Executive Director Doles read into the record. Proposed Resolution 2020-2316. A MOTION was made by Commissioner Ledonne to approve Proposed Resolution 2020-2316, Approving the Execution of a Revised Recapture Agreement with Alton Industries Ltd. Group and the extension of the Inspection Period until January 8, 2020. The motion was seconded by Commissioner Chavez. Attorney Luetkehans stated that the original Recapture Resolution 2019-2312 was passed by the Board at the November 20, 2019 meeting and at that time there was a blank in the Agreement for the actual amount of the recapture costs. He continued that Alton's engineer estimated the recapture amount to be \$50,000. Attorney Luetkehans stated at the time it was not clear that the looping of the watermain was a requirement by the City of West Chicago which was significant extra costs. Discussion followed and Attorney Luetkehans explained the revised recapture agreement estimates costs at \$339,736 with \$150,000 in costs on the

adjoining property. Alton Industries has advised they would be willing to remove costs such as soil contingency and contractor overhead and profit. Alton Industries is now seeking \$150,000 in recapture costs to be paid to them upon closing of the adjoining property. After continued discussion the **motion was passed** by roll call vote (7-0).
